Kementerian Energi dan Sumber Daya Mineral telah mendapatkan hibah dari Bank Dunia untuk melaksanakan *Indonesia Infrastructure Support (INIS) Trust Fund Grant TF 0A0405 Improving Energy Project Delivery (IEPD) Project*. Proyek ini telah berjalan sejak bulan Juli 2015 dengan tujuan untuk mendorong terwujudnya peningkatan transparansi dan tata kelola pemerintahan yang baik di Kementerian ESDM, khususnya dalam penyelesaian proyek-proyek berkaitan dengan energi.

Saat ini, Bank Dunia sedang melakukan proses Restrukturisasi dan perpanjangan atas pelaksanaan Proyek ini, dengan usulan komponen proyek sebagai berikut:

- E. *Support and facilitation of Project implementation, which include support to the Project Implementation Unit of the Project*

The project has been implemented since July 2015.*
